1. What is Chartered Accountancy (CA)?

- Chartered Accountancy (CA) is a professional course in accounting that equips you to deal with areas of Accountancy, Auditing, Cost Consultancy, Taxation, Legal Matters and Management Consultancy. The course involves a blend of theoretical education and practical training which run concurrently for a period of three years and equips a student with knowledge, ability, skills and other qualities required for a professional accountant.

2. Who can study Chartered Accountancy?

- Students who have passed/appeared in final year of +2 examinations from any stream can join Chartered Accountancy starting from CAP-I under ICAN.

3. What is the governing body of CA Studies?

- Prospective students with the said criteria can register through the Institute of Chartered Accountants of Nepal (ICAN) to pursue the CA Studies.

4. What is ICAN?

- ICAN stands for The Institute of Chartered Accountants of Nepal, an autonomous body established under Chartered Accountants Act, 1997, enacted by parliament of Nepal to regulate CA profession in Nepal.

5. Which University imparting CA education?

- No university in the world imparts CA education; every country has its autonomous body established under the Act of Parliament, like The Institute of Chartered Accountants of Nepal (ICAN) for Nepal. Students have got registered with the Board to pursue study.

6. What are the eligibility criteria to study Chartered Accountancy under ICAN?

Level	Required eligibility
CAP*-I	At least 10+2 passed or result awaiting students in any discipline or non-exempted Graduates.
CAP*-II	CAP-I passed or Exempted Graduates. <i>Exempted Graduates</i> a. Commerce graduates having not less than 50% marks. b. Non-commerce Graduates having not less than 60% marks.
CAP*-III	CAP-II Passed

* CAP- Chartered Accountancy Professional

7. What is the duration of Chartered Accountancy Course under ICAN?

Level	Duration
CAP-I	6 months
CAP-II	9 months
CAP-III	3 years (with articleship period)
Total:	4 years 3 months

8. What is articleship?

- A student is required to undergo about 3 years of practical training known as **articleship**. The Chartered Accountancy course, thus, involves a unique blend of compulsory theoretical education and practical training, which runs concurrently for a period of 3 years. Theoretical knowledge is integrated and reinforced with practical training. The practical training of 3 years should be done after the completion of CAP-II under ICAN.

9. What are the Course Modules of CA Studies under ICAN?

- Cost & Management Accounting
- Business Communication & Marketing
- Income Tax & VAT

CAP-III

The CAP-III Level consists of eight papers; each paper carries 100 marks and divided into two groups:

Group-I

- Advanced Financial Reporting
- Advanced Financial Management
- Advanced Audit & Assurance
- Corporate Laws

Group-II

- Management Information & Control System
- Advanced Taxation
- Advanced Cost & Management Accounting
- Strategic Management & Decision Making Analysis

10. What are the dates of registration for Chartered Accountancy Course?

- Registration is open throughout the year to eligible students. However as the examinations are held in June and December under ICAN. Registration Calender and necessary assistance is available at CCMA office.

11. Is it really hard to study Chartered Accountancy as is generally understood?

- As the saying says, “Nothing is possible for those, who do nothing” Chartered Accountancy education requires in depth dedication and regular labour with genuine effort for the successful completion of the course.

12. Where are the examinations held?

- Under ICAN, the examination centres will be inside & outside the Kathmandu valley as directed by ICAN.

13. Is there any restriction in number of attempts?

- Under ICAN, for CAP-I and CAP-II students can attempt up to 3 years and 5 years respectively from the date of initial registration at ICAN. For CA Final level there is no restriction in number of attempts.

14. Is it possible to study College programs while studying CA?

- Yes, it is quite possible as well as a need for CA professionals to gain more market opportunities and exposures. However, Students are advised to join BBS program.

15. What are the scopes/ job opportunities of Chartered Accountants (CA)?

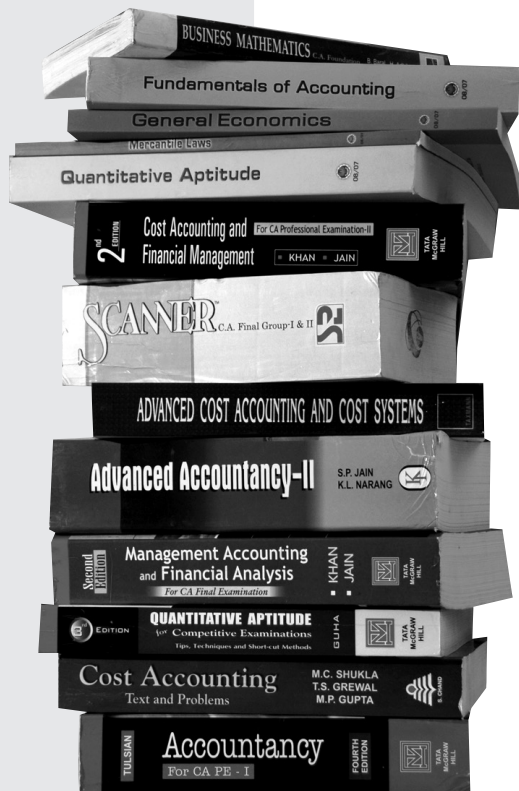
- Chartered Accountants occupy the prominent role of higher-level executives in our economy and society. Members of this profession play a dominant role in:

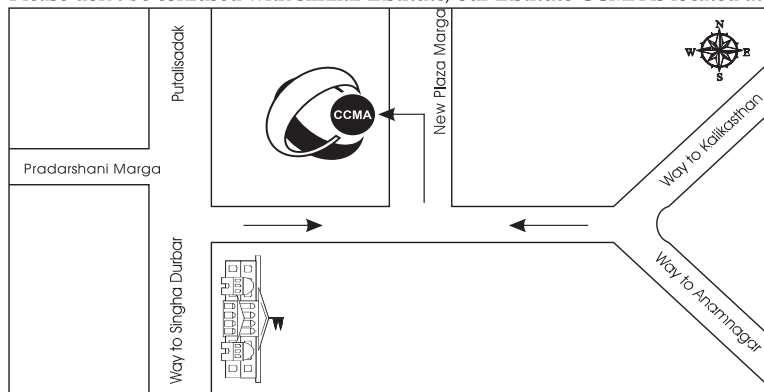
